Aims and Scope

The *Journal of European Landscapes* is a peer-reviewed, open-access journal launched to accelerate research and free information exchange in European landscape research. In addition to local and national focused journals the *Journal of European Landscapes* wants to stimulate debate, research and other forms of international cooperation.

The *Journal of European Landscapes* aims to offer a platform for interdisciplinary research into landscape. The historical and heritage dimensions of landscape are important, but the spatial, physical, visual, representational, philosophical and other landscape dimensions are also included. In many cases this requires interdisciplinary research across academic disciplines ranging from archaeology, anthropology and art history, to geography, earth sciences, economics, tourism studies and sociology. The *Journal of European Landscapes* aims to publish studies on the historical and heritage aspects of landscape against the backdrop of challenges that Europe is facing today: the challenges of European unification, international cooperation and conflicts, migration, climate change, energy transition, increase of tourism, digitization and urbanization.

Publication Ethics

Amsterdam University Press and the editors of the *Journal of European Landscapes* endorse the COPE (Committee on Publication Ethics) guidelines and will pursue cases of suspected research and publication misconduct (e.g. falsification, unethical experimentation, plagiarism, inappropriate image manipulation, redundant publication). By submitting an article for review to this journal, the editors and the publisher will understand the author agrees to adhere to the principles and practices as set out in [AUP's Ethics and Malpractice statement](#). Editorial Procedure

This journal uses a double-blind peer review process, which means that both reviewer and author's names are concealed throughout the review process. To facilitate this, authors need to ensure that their manuscripts are prepared in a way that does not reveal their identity. The editorial board decides whether to accept, conditionally accept or reject the manuscript. If the article is conditionally accepted, it will be returned to the author for revision, upon which the editors take the final decision to accept or reject the article for publication. Authors will need to sign a Consent to Publish Agreement prior to publication.

The editors will endeavour to review your article as quickly as possible, but they are reliant on the availability of suitable referees. To expedite the review process it is important to follow the directions given in this document and address any recommendations given in the review reports in a separate document when you submit your revised manuscript to the managing editor.

This journal provides immediate open access to its content on the principle that making research freely available to the public supports a greater global exchange of knowledge. This is a **Diamond Open Access** journal: it provides immediate open access to its content on the principle that making research freely available to the public supports a greater global exchange of knowledge. Authors do not have to provide open access charges to publish in this journal. The journal is financially supported by the Centre for Global Heritage and Development (Leiden University, Delft University of Technology and Erasmus University Rotterdam) and CLUE+ (VU Amsterdam).

Authors keep the copyright to their articles but are required to sign a Consent-to-Publish form based on the CC-BY 4.0 license. You can download the form from the AUP website [here](#).

It is the author's responsibility to seek permission for the use of any copy-righted materials from the rights-holders and pay for any fees required. In case of doubt whether permission is needed, please contact the publisher (details below).

Voluntary article processing charge

For publication in Open Access for this journal, no contribution by the author is obligatory. So far, the journal has been able to support all publications in Open Access thanks to the support of our sponsors.. Yet the editorial board strongly advises researchers in funded projects to make a voluntary contribution to the journal. As an indication, a research paper costs € 1000,- to publish, whereas a project description, interview or book review costs €500,-. Author Guidelines

The *Journal of European Landscapes* considers the following papers:

- 1. Scientific papers:** The *Journal of European Landscapes* will publish articles that transcend national borders and have an international (comparative) perspective on landscapes. The Journal also welcomes more general and theoretical papers on the concept of landscape. The focus will be on the history and heritage of European landscapes, including rural as well as urban and industrial landscapes. Contributions are generally between 5000 and 600000 in length, including references.
- 2. Project descriptions:** The *Journal of European Landscapes* wants to document and share the outcomes of finished projects on European Landscape, particularly those in which a heritage and history perspective is prominent. This way the outcomes of these projects are retraceable and the relevance of these projects for the study of European landscapes becomes concrete. Integrated in the article should be: research question, period of projects, participants, foreseen results, url of website, list of publications, academic and social impact. Contributions are generally between 1000 and 1500 in length, including references. Contributions ideally include one to three images and/or maps.
- 3. Book reviews:** The *Journal of European Landscapes* aims to publish reviews of books that address European landscape in their heritage and historical dimensions. By doing so, the journal aims to stimulate discussion and reflection on current European landscape studies' publications. Integrated in the article should be: general information on the book (title, author, number of pages, publisher), introduction on the

author, short summary of the book's content and most important conclusions, reviewer's opinion on the book. Contributions are generally between 1000 and 1500 in length, including references.

4. **Interviews:** The *Journal of European Landscapes* will profile influential scholars that made and/or still make a significant contribution to our knowledge of the history and heritage of European landscapes. Contributions are generally between 2000 and 2500 in length, including references.

Preparing your manuscript

Articles should be submitted to our editorial platform Manuscript Manager:

Research papers should not be longer than 6250 words (including references). For illustrations please subtract 400 words per page (e.g. half page illustration, minus 200 words) The journal accepts articles written in British English only. Please upload your article as a Microsoft Word file, including a list of works cited at the end of the article.

For references and general principles of style, the journal uses the author-date system following the Chicago Manual of Style, 17th edition. A quick guide to the main citation forms and a Q&A can be found on the CMS website. https://www.chicagomanualofstyle.org/tools_citationguide/citation-guide-2.html

The journal uses British English and in the case of a conflict between the Chicago Style and British English, the latter will prevail.

- You should submit an abstract of not more than 150 words and 5-8 keywords that accurately describe the subject of your article. A list of citations/bibliography should be included to allow cross-referencing by CrossRef.
- Any section headers should be marked clearly as a header. Do not number section and do not use more than one sub-heading.

Illustrations

The *Journal of European Landscapes* invites authors to include illustrations in their manuscript.

Quality

Please ensure your illustrations are of the highest quality possible, both in terms of technicality (sharpness, contrast, legibility of lettering, etc.) as well as power of expression. Ideally submit original, not yet screened, scans of maps, photographs etc. Please try to obtain original illustrations as much as possible, with permission to publish. Scans from printed matter are usually of insufficient quality due to the grid in prints.

If you submit contemporary maps of old situations, please make sure that the map does not contain more information than necessary, so that the map image remains clear. You may always consult the editor in case of doubt. A map must have a north arrow, a scale indication and a clear legend. The editorial board is free to refuse images of insufficient quality. In principle, this does not happen without consultation with the author.

Caption

Please submit a caption with each illustration and make sure the number of this caption correlates with the file name of said illustration. Images or graphs will be numbered in the journal and the body text may refer to these illustrations. You may specify at what height of the text an image should ideally be located.

A caption should include the following elements, aside from the optional illustrative and explanatory note: the nature of the representation, date, name of the creator or rightholder (see Rights). For example:

- The 'Klyne Kerk tot Edam', by Cornelis Pronk, 1777 (Rijksmuseum, Amsterdam).
- Openingsvergadering Internationaal Stedebouwcongres, Amsterdam, June 1924 (Bloemers, 1930, p. xi).
- Tobruk observation bunker in a natural preserve on the Danish Wadden island Rømø. The inscription in the concrete slab provides details about the previous military functions of the bunker (photograph by author).

Submission

Generally, we encourage authors to submit illustrations with the highest possible resolution. An image spanning the full width of a page should be at least 1800 pixels (dots) wide, an image the width of a column 900 pixels. This equates to a minimum dpi of 300. If you want only a part of the submitted image to be featured, the submitted file should be of a higher resolution in general. In this case, please submit a clear print or photocopy that clearly describes the cutout.

Please note: illustrations downloaded from the internet often have a lower resolution. When in doubt, please request the editor to check the resolution of the submitted files.

Maps

Maps with text should ideally be submitted as eps or PDF files, so the file may be edited and displayed according to the guidelines of the journal.

Image source

A scan of a rasterized image may not be usable. Because of this, it might be necessary to retrieve the source file: the original map, photograph, or drawing. A publication often indicates the location of the original, such as an archive, museum, or image bank. You may then order a scan of the original illustration from said institution. This may require a payment, and a delivery time of a few days or weeks should also be taken into account. Many contemporary topographic maps are freely available and may be downloaded from <https://www.pdok.nl/nl/producten/pdok-downloads/basis-registratie-topografie/topraster/toprasteractueel/top25raster>.

Rights

In accordance with copyright law, the creator of a work (photograph, map, drawing, painting etc.) must give permission for the use of their image up to 70 years after their death. This permission to use is usually

granted for a fee. Costs vary from a 'free copy' to a few tens or hundreds of euros (for photographs by photographers or paintings from private museums). If you mention the image is intended to be used in a small scientific journal, the costs are usually not too high. Institutions and museums are increasingly offering high resolution downloads of their images for free.

It may be difficult to track the original rightsholder of an image, especially in the case of older imagery. In such cases, the only solution may be to publish without explicit granted permission. In such events, please ensure that you can demonstrate to have made extensive efforts to find the rightsholder. The institution that holds the original image may also set (financial) conditions for the publication of an image. Please inquire about this before placing an order. In addition, some institutions charge fees for the scanning and submission of their images to a customer. Finally, it is a legal obligation to state the name of the creator, and some institutions also demand their name be states. The author is responsible for arranging image rights and properly refer to sources. If this was not possible for some reason, the author must indicate this very clearly.

Tables and graphs

For tables and graphs, please also submit the source file (in Excel), so the typesetter may adjust the design of the table or graph according to the measurements and design of the journal.

Publication

The *Journal of European Landscapes* is an Open Access journal. This means that your article will be published online in immediate open access and you are allowed to publish the version of record on your own website too. AUP will publish your article on a professional platform with all the relevant metadata.
