Aims and Scope

Fascism: Journal of Comparative Fascist Studies publishes peer-reviewed (double blind) articles that explore the phenomenon of fascism in a comparative context. The journal achieves range and depth of knowledge by focusing on topics such as:

- The unique as well as generic aspects of fascism.
- Patterns in the causal aspects and genesis of fascism, including political, economic, social, historical, and psychological factors.
- Expression of fascist themes in art, culture, ritual and propaganda.
- Gendered dimensions of fascist politics and culture.
- The global and wider historical contexts of fascism.

- Elements of continuity and change between interwar and postwar fascisms, as well as consideration of contemporary forms of fascism.
- Examination of fascism using themes and analytical concepts including revolution, modernity, modernism, colonialism, political religion, totalitarianism, capitalism, transnationalism, extremism, charismatic dictatorship, patriarchy, racism and terrorism.

Many articles in the journal follow the major research article model, and it welcomes submissions from early-career scholars as well as established researchers. The journal is also keen to encourage submissions of shorter, provocative position pieces, review essays mapping new developments in the field, and discussions that enrich the interdisciplinary study of fascism as a broad field of enquiry.

Open Access

Fascism is a diamond open access journal (<u>CC-BY 4.0</u>) and provides immediate open access to its content on the principle that making research freely available to the public supports a greater global exchange of knowledge.

For publication in open access for this journal, no article processing charge (APC) by the author is obligatory and authors keep the copyright to their works. The journal supports all its content in open access thanks to the support of our sponsors: NIOD Institute for War, Holocaust and Genocide Studies (Amsterdam, the Netherlands), and the International Association for Comparative Fascist Studies (COMFAS). Style Sheet

All articles must contain the following elements:

- Title
- Subtitle (optional)
- Name(s) of Author(s)
- ORCID (optional)
- Affiliation(s) of Author(s)
- English-language Abstract of 150-200 words
- 5-8 keywords

Production Process

When the final version of your article has been completely accepted, it will be sent for production to a staff member at AUP. The manuscript will be formatted by a professional typesetter and you will receive a PDF proof for checking. You are urged to check and return the proof within the given time period to the managing editor. Typographical and factual errors should be indicated in the PDF using the Comment and Mark-up toolbar in

SPECIFIC STYLE CONSIDERATIONS

General

Submitted manuscripts should be double-spaced (including footnotes, which should appear at the bottom of the page). Keep formatting to an absolute minimum. Use italics only to format the text which has to be typeset as italics. Indent paragraphs with a single tab.

Language

Manuscripts should be written in English. American and British spelling should not be mixed and should be consistent throughout. The preferred form of English is British

English, unless the author is a native speaker of American English. The text must be grammatically correct and in good literary style. The manuscript should have been checked before submission by a qualified native speaker.

Length

Articles should consist of approximately 8,500 to 10,000 words.

Manuscript Structure

Abstract and Keywords

Submissions must include an abstract of a maximum of 200 words and 5 to 8 keywords.

Headings

All headings should be aligned flush left and unnumbered.

First level headings should be in bold, 2 lines of white above, one below; second level headings in bold italic, 1 line of white above, none below; third level headings in roman, with 1 line of white above, none below.

Footnotes

This journal uses footnotes and a bibliography. The bibliography is used for citation indexing. Footnotes should be numbered consecutively (using Arabic rather than Roman numerals), double-spaced, and in the same font size as the main text. A note number may be used only once: sub-numbering of notes (e.g. note 30a) is not acceptable.

Authors should eliminate lengthy discursive notes either by omitting the material or by working it into the narrative body of the text. Do not attach notes to the title. Notes with acknowledgements should be avoided. Acknowledgements should be added to the titlepage document when submitting your article.

Quotations

If they are brief (5 lines or fewer), quotations should be run on with the text. The practice is that single marks are used first (') and then (") double quotation marks.

Longer quotations should be indented, without quotation marks. All indented quotations should be typed double-spaced.

Translations & Abbreviations

Non-English book/journal/article titles and non-English expressions in the running text are written in italics in the original language. The English translation is written between parentheses (not in italics). Please use square brackets in the footnotes.

Non-English proper nouns, like names of organisations and political parties, are generally *not* italicised. The abbreviation or/and English translation is written between parentheses.

Figures

All figures must be cited consecutively in the text. Figures should be submitted as separate source files in .eps, .tif, or .jpg format, in a size suitable for the typesetting area of the journal. The resolution of these files should be at least 300 dpi for half-tone figures, and 600 dpi for line drawings.

Number the files and clearly mark the spot where the photo should be inserted ("insert ill. 2").

Photocopies or scans from books are not acceptable, since they will reproduce very poorly. For art images, captions should include the artist's name (if relevant/known), title and/or description of the artwork, year of the artwork, year or time period (if known), medium, size, and archival location.

Figure Captions

Provide a list of captions for all illustrations and photographs at the very end of the article, typed double spaced. Identify the illustration by its number, describe it with a concise caption (include the location and date, if relevant/known), cite the full source, and acknowledge credit (permission granted). For art images, captions should include the artist's name (if relevant/known), title and/or description of the artwork, year of the artwork, year or time period (if known), medium, size, and archival location.

Tables

Tables should be numbered and identified by number and by title. (For example: Table 3 Agricultural Production, 1935-1945.) Where necessary, include source and/or credit.

Numbers

Spell out numbers from zero to ninety-nine; century numbers (nineteenth century); round numbers such as one hundred or one thousand; fractions and numbers that begin a sentence.
