



# Call for Papers - Journal of European Landscapes

## Special Issue: Beyond European Landscapes— Tracing entangled European legacies in landscapes outside Europe

The editorial board of the *Journal of European Landscapes* invites scholars, landscape architects, historians, geographers, and other specialists to submit papers for a Special Issue dedicated to **landscapes outside Europe**.

While European landscapes are often studied within the geographical boundaries of the continent, numerous examples exist across the globe where European sociopolitical influences resulted in hybrid landscape forms, structures, and practices taking root and evolving in overseas contexts. These landscapes are shaped by factors including colonialism, colonial slavery and extraction, migration, trade, religious expansion, power asymmetries, and cultural exchange; Their study offers a unique perspective through which to examine the diffusion, transformation, and political potential of the concept of landscape itself, especially amid the urgent need for further decolonization and in the context of the climate crisis.

The Special Issue remains open to the examination of any landscape outside Europe that can be studied as an entanglement between local communities and legacies of European colonization, expansion, or influence. We invite novel theoretical and methodological frameworks, building on decolonization studies, critical heritage, the environmental humanities, landscape archaeology, critical geography, architecture and city history, and other related fields. We welcome contributions that explore, but are not limited to, the following subthemes:

### 1. Colonial Landscapes and Heritage

- European landscape architecture and urban planning in former colonies
- Plantation systems, military infrastructures, and missionary settlements
- Indirect impacts of European colonialism in extractive landscapes

### 2. Migration and Diaspora

- Landscapes shaped by European communities abroad
- Transnational networks and cultural landscape practices

### 3. Reception and Hybridization

- Local interpretations and adaptations of European landscape forms
- Interactions or confrontations between European and Indigenous landscape knowledge

#### 4. Landscapes of Memory and Identity

- Cemeteries, monuments, and ceremonial spaces of European origin
- Landscapes as expressions of contested memories and identities

#### 5. Ecological and Agricultural Transformations

- Environmental degradation associated to the expansion of European financial or political interests
- European agricultural models and their impact on overseas ecologies

#### 6. Landscape of Resistance and Place-making

- Indigenous knowledge systems and Indigenous geographies
- Maroon landscape, resistance, and agency

### Submission Guidelines

- Abstracts of max. 150 words (accompanied by 3-5 keywords) by March 1<sup>st</sup>, 2026
- Full papers (6,000–8,000 words) by October 1<sup>st</sup>, 2026
- All submissions will undergo double-blind peer review
